## **Treasurer's Report**

Questions from Administrative Coordinator Jack Straub:

- detail from invoices, for example attorney invoice
  - Mr Manfredi indicated detail has historically been presented to executive committee; because of attorney client materials we made it available to the board but not as part of the public record
- -other invoices not included in Treasurer's report
- -bank reconciliation shows payments already made
  - Mr Manfredi recommended financial policy should be amended to allow ratification by the board of invoices already paid

- financial statement numbers will be off for 2024 because last two assessment checks for 2023 were not deposited until January 2024, KBBC quickbooks are on a cash basis
- unknown why audits and IRS tax filings are accrual basis
- audit for 2022 has not been completed
  - Mr Manfredi stated the auditor will attend the March 13 KBBC meeting to present both 2022 and 2023 audits
- 2022 IRS tax filing deadline was November 15, 2022
  - Mr Manfredi indicated he sent the IRS penalty notifications from past years to the auditor, and was told an abatement application would be submitted to the IRS once the current taxes were filed

#### **Social Media**

- would like to highlight women owned businesses for March, will send email with form
- Melissa may have list of women owned businesses
- promoting St Patrick's Parade

#### **Administrative** Jack Straub

- BID assessment checks for first two quarters of 2024 were received today, will be deposited immediately
- emails and phone messages in KBBC office are completely caught up
- office phone is operational again, had to be reset
- visitkeyport domain was renewed but is not being used for emails, could go back to
- ribbon cuttings 3 new businesses are ready and have COs
- last two Saturdays in March are St Patrick's Parade and Holy Saturday, recommend hold ribbon cuttings on first Saturday in April, which is April 6
- President Araneo asked if welcome packets for businesses could be updated
- 1099s had been mailed to KBBC, they were mailed out upon receipt
- there were several outstanding invoices from 2023, one for Three Hugos Landscaping to cut grass on Valley Bank property where KBBC sign is located; website directory invoice submitted by Larry Vecchio; Matawan Sign invoice for second highway sign
- will check with Yulia to get access to mailchimp email addresses
- discussion of where to place second KBBC sign on Valley Bank property
- President Araneo said we should determine if we need DOT permission
- contingent on DOT outcome, motion by Melissa OConnell to place second sign in location adjacent to Hwy 36 eastbound, seconded by JoJo Merla, voice vote all approved

#### **Events** Melissa OConnell

- Borough Council approved KBBC budget last night
- only event we don't yet have date for is Stakeholders Meeting, sometime in April
- first event is Hop n Shop, Saturday March 16
- moved Restaurant Week to April
- Taste of Keyport may be later in year; we have event TBA date for October 12
- car shows will need details
- -Jay Faltings stated Pastor Mike would like to donate approximately 75-100 flower seedlings to give out during one of our early May events (for Mothers Day), car show is too late
- Melissa will add to Cinco de Mayo
- two concerts on the bay, second is TBD
- first car show June 20 may need to move to rain date due to high tide
- October 5 switched to Halloween costume stroll, with movie by Keyport Recreation
- also collaborating with Recreation on Trunk or Treat
- first dog event will be on West Front Street, second will be on American Legion Drive
